Zorlu Enerji has announced on November 15, 2024 that the Capital Markets Board had approved the Company's application to issue debt instruments up to a nominal value of TL 5,000,000,000 and with a maximum maturity of 5 years for sale in single or multiple tranches to qualified investors in the domestic market within one year following the receipt of the issuance certificate. Within this scope, the Company completed the sale of a TL 440,930,000.00 corporate bond with floating coupon payments with a maturity of 376 days to qualified domestic investors on July 11, 2025. Ak Yatırım Menkul Değerler AŞ has acted as the financial intermediary for the issue. This statement was translated into English for informational purposes.
