By placing these values at the center of our business practices, we respect the existence, roles, and responsibilities of the institutions and organizations with whom we establish relationships.

As one of the leading companies in the energy sector, we are aware of the necessity of prioritizing renewable energy investments for the establishment of a sustainable future in our country and the world. Accordingly, we engage in advocacy and collaborations based on scientific principles in public, civil society, and private sector platforms to prioritize these investments.

PUBLIC POLICY

We believe that responding transparently to the needs and expectations of all our stakeholders is of utmost importance for our sustainable business performance. Public institutions and organizations, regulatory authorities, local governments, and civil society organizations are our primary stakeholders who directly impact our business. As part of our responsible lobbying approach, we conduct visits and meetings with policymakers, regulatory authorities, local governments operating in our investment areas, and civil society organizations, regardless of any political views, with a focus on serving the highest benefit to society. We also participate in various joint projects for the public good and voluntarily share our expertise in the energy field on a scientific basis.

We value the opinions of all our stakeholders and with an accessible understanding, we ensure the continuity of communication, both on physical and digital channels. TRANSPARENCY AND ETHICAL PRINCIPLES

In our activities conducted in the economic, social, and environmental fields, we adhere to the principle of maintaining an equal distance among public institutions, non-governmental organizations, and political parties. We maintain a non-partisan communication and avoid engaging in financial or non-financial relationships with public officials, political individuals, and representatives, in compliance with relevant laws and regulations. We do not provide financial support to any political party or organization. The decision of our employees and managers to participate in any political activity or social engagement, as well as contribute to them, is personal. We do not allow activities in the workplace that involve propagating their political beliefs or engaging in activities aimed at spreading political thoughts on political issues. We do not allocate company resources (such as vehicles, computers, email, etc.) for political purposes.

As Zorlu Enerji, we adhere to Zorlu Holding Code of Ethics. In this regard, we never offer cash, gift vouchers, or any equivalent value as gifts to our public stakeholders, and we do not accept such offers from them. We do not encourage public officials to violate their code of professional conducts. In accordance with the principles outlined under the title of "Conflict of Interest - Corporate and Personal" in Zorlu Holding's Ethical Principles, while giving or receiving gifts, or engaging in representation and hospitality, we prioritize the criteria of "being moderate" and "avoiding any negative impact on the company's reputation in the level of our stakeholders or third parties. This applies not only to all our stakeholders but also to public officials. In our relationships with legal regulatory institutions and organizations, we prioritize open, complete, accurate, and timely communication. We approach all domestic and foreign institutions and organizations without discrimination when conducting our activities and fulfilling our legal obligations. We obtain information from reliable sources and do not spread false information.





If we receive a notification regarding the misrepresentation of our officials to deceive third parties and/or public personnel, we handle such claims with an investigation and audit within the scope of our company regulations and Code of Ethics. We respect the confidentiality of our former public personnel employees and ensure the protection of personal data of all our employees in accordance with the rules of the Personal Data Protection Law (KVKK).

As a publicly traded company, we announce our company's commercial activities, shares, and government incentives through the Public Disclosure Platform (KAP). Since there is no specific legal regulation governing lobbying activities in Türkiye, we regulate our activities through our company regulations and align our practices with international agreements. In this regard, we establish internal and external audit mechanisms to ensure transparency and openness. Under the umbrella of Zorlu Holding Audit Group Presidency, audit teams operate based on the International Internal Audit Standards to audit financial and operational processes, within the scope of the annual plan approved by the Board of Directors. Additionally, in case of a notification concerning a violation of business ethics in stakeholder relations, including lobbying activities, the Internal Audit and Ethics Directorate conducts a separate investigation and audit, and the results are reported to the Ethics Committee for further action. In 2022, no notifications about concerning violations of business ethics, including those related to the deals with the public institutions, were received for Zorlu Enerji Group Companies' employees.

We transparently disclose our collaborative efforts and financial support in sectoral topics until today. At Zorlu Group, we aim to direct our corporate donations and social support in a way that best contributes to our society. To this end, we focus our donations and social support on projects, institutions and organizations that will strengthen Zorlu Group's reputation, socially beneficial activities and the people and organizations associated with these activities, public benefit accounts and non-profit organizations.

To ensure diversity, capacity, and resource balance between institutions, we engage in lobbying activities in various areas, such as top tier universities, local governments, and institutions operating in the energy sector. We commit to providing up-to-date, honest, and comprehensive information to the public, and since 2021, we continue to publish information regarding our financial support on our corporate website. We will continue to announce the developed cooperations and supported projects at the end of each year.

ADVOCACY ACTIVITIES

Zorlu Enerji conducts advocacy and lobbying activities through membership in various trade associations and non-governmental organizations, aiming to contribute to sectoral development and promote sustainability goals.

1. Lobbying and Trade Association Membership Management System

Our company manages lobbying activities and trade association memberships through a transparent and ethical management system. This system ensures that our activities are aligned with our sustainability goals and corporate values.

Policy and Governance Mechanism

All lobbying and membership activities are conducted in accordance with the highest ethical standards, adhering to principles of anti-bribery and conflict of interest management. These activities are regularly reviewed and approved by senior management and the Board of Directors.

Transparency and Accountability

Details of lobbying activities and membership fees are disclosed in our internal and external reports. When discrepancies arise between associations' positions and company policies, we pursue constructive dialogue.

Alignment with Sustainability

All our activities are carried out in line with Zorlu Enerji's sustainability objectives, climate action strategies, and the United Nations Sustainable Development Goals. Our contributions to public policy aim to create a sustainable business environment that considers the interests of all stakeholders.

Collaboration with Trade Associations and NGOs

Zorlu Enerji actively participates in various platforms, including TÜSİAD, the Turkish Business Council for Sustainable Development (SKD Turkey), the Technology Development Foundation of Turkey (TTGV), the UN Global Compact, and the Geothermal Energy Association. Through these platforms, the company contributes to sectoral policy and regulatory processes and conducts awareness-raising initiatives in collaboration with various stakeholders.

- **TÜSİAD:** Participates in the Energy Working Group and the Environment and Net Zero Policies Working Group, supporting the inclusive implementation of MRV (Measurement, Reporting, and Verification) processes for greenhouse gas emissions and contributing to cross-sector knowledge sharing.
- **SKD Turkey:** Contributes to the Renewhub project under the Renewable Energy Project Group, ensuring high participation in events and webinars. Supports young leaders in developing sustainability-focused innovative proposals through the Young Impact Program.





• **TTGV:** Shares knowledge in the Hydrogen Working Group and Carbon Capture, Utilization, and Storage Working Group under the Climate Lab Community, promoting the dissemination of best practices.

As a member of UN Global Compact Turkey, Zorlu Enerji complies with global principles on human rights, labor standards, environment, and anti-corruption.

- **Utilized Services:** Participation in the association's training and capacity-building programs and access to information and resource-sharing platforms.
- Transparency and Reporting: Sustainability performance is tracked and publicly shared in accordance with international standards through the annual Communication on Progress (CoP) report.

Geothermal Energy Lobbying

As a company generating 100% of its production from renewable energy, Zorlu Enerji conducts lobbying activities for geothermal energy, a significant portion of its investments, through the Geothermal Energy Association, of which it is a founding member.

• Awareness Activities: Various channels, including TV programs, university panels, press releases, and media communications, are used to raise public awareness of geothermal energy as a clean and renewable resource.

2. Lobbying Responsibilities up to C-Level Executives

Responsibilities for public policy interactions are assigned to senior leadership.

- Senior Management: At the CEO and General Manager level, public policy strategies are defined and submitted for Board approval. The Board monitors the ethical compliance and alignment of lobbying activities through the Audit Committee. Critical communications with stakeholders, including investors, local authorities, and employees, are managed by top management. Feedback on societal needs is collected semi-annually through the Corporate Communications and Marketing Directorate.
- **Relevant Departments**: Corporate Communications, Sustainability, and Legal departments manage daily interactions and operational processes, planning and executing activities collaboratively.
- Accountability: Records of all activities, objectives, and expenditures are meticulously kept, regularly reviewed by internal audit mechanisms, and transparently shared in sustainability reports.

This structure ensures that our contributions to public policy are transparent, ethical, and aligned with the company's long-term goals.

3. Climate Change Policy Statement (Aligned with the Paris Agreement)

Zorlu Enerji has adopted a climate policy aligned with the Paris Agreement. We share knowledge within renewable energy and mobility associations, raise awareness of efficient energy use, and engage with business leaders to highlight the role of clean energy in economic growth. We also closely monitor sector developments.





As a member of the Climate Platform, jointly established by the Regional Environmental Center Turkey (REC Turkey) and TÜSİAD, Zorlu Enerji supports joint business action on low-carbon transition, technology transfer, financing, and carbon management.

4. Reviewing and Monitoring Lobbying Activities for Paris Agreement Alignment

The company continuously reviews and monitors its advocacy and lobbying activities on climate change to ensure alignment with the Paris Agreement. We advocate for the implementation of the Climate Law, related regulations, and MRV processes, supporting an inclusive national transition to a low-carbon economy. Additionally, we aim to bridge knowledge gaps among actors, consultants, verifiers, and government units across sectors.

5. Framework for Addressing Misalignments between Trade Association and Company Climate Positions

Zorlu Enerji plans all activities in alignment with corporate strategy, balancing public interest and supporting net-zero and low-carbon economy goals. While pursuing renewable energy-focused growth, we monitor the climate policies of trade associations we are members of or collaborate with. In case of misalignment with Zorlu Enerji's climate goals, the issue is evaluated with relevant units, corporate membership is reviewed, and if necessary, membership is terminated with senior management approval, ensuring ethical, transparent, and consistent action in climate change matters.

In line with our commitments, we continue to work toward achieving net-zero carbon emissions across our value chain, aligning our 2030 and 2040 targets with the Science Based Targets initiative (SBTi) and the Paris Agreement. SBTi's approval validates our actions in addressing the climate crisis as consistent, transparent, and effective. Our 2030 and 2040 targets are presented in the table below
